Following will be functions of the NUAIP:-

1. The NUAIP shall consider the recommendations of Departmental Academic Integrity Panel (DAIP).
2. The NUAIP shall also investigate cases of plagiarism as per the provisions mentioned in these regulations.
3. The NUAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff of University.
4. The NUAIP shall have the power to review the recommendations of DAIP including penalties with due justification.
5. The NUAIP shall send the report after investigation and the recommendation on penalties to be imposed to the President within a period of 45 days from the date of receipt of recommendation of DAIP/ complaint / initiation of the proceedings.
6. The NUAIP shall provide a copy of the report to the person(s) against whom inquiry report is submitted.
